**NARRATIVE**

On the listed date and time VI#1 came on station to report an offense, which occurred while visiting IO#1-IO#2, and was perpetrated by SU#1-SU#2. A copy of this report was forwarded to St. Bernard Sheriff's Office and Department of Defense. VI#1 was advised a copy of this report will be on file. VI#1 advised this officer; "In 2003 I took a trip to Louisiana to visit J.D. Acosta [IO#1] and Kathy Acosta [IO#2]. It was May 9, 2003. Lisa [SU#2] and Eric [SU#1] drugged me and Lisa raped me. All I remember is drinking Dr. Pepper, at a bar on Bourbon Street. I was incapacitated. They carried me to the car and Lisa pulled down my pants and performed oral sex on me. I could not move, I was drugged. They drove me to a house without furniture, I heard rattling of silverware. I asked where is J.D.? They took me into a back room and laid me on a mattress. Eric tried to insert his penis into my vagina. I grabbed Eric's penis and said "your dirty". I sat up and there was a six inch knife behind me on the mattress. I picked up the knife and yelled; "I'm going to gut you like a motherfucking fish". I asked where J.D. was at and they told me, that he was at the hospital from an altercation at the bar. At knife point I made them drive me to the hospital. I got out of the car and left the knife in the back seat. I found J.D. in front of the hospital smoking a cigarette and asked J.D. why Eric and Lisa had a knife. J.D. got real quite. J.D. told me that Eric and Lisa could take me back home. I didn't go with them. I stayed up for three days. I tried to medicate myself with cough syrup to make me go to sleep. I did go to the police and they tried to take me to the Army Base [Fort Polk]. I was in the reserves at the time. After three days I left and came back home. I reported the sexual assault to my commanding officers [IO#3-IO#4]. They said they could not do anything for me, because I was only in the reserves. It ruined my military career. From then on no one trusted me. I tried to contact J.D. on facebook to try to get Eric and Lisa's last name. I told him I was going to prosecute. J.D. has not responded. I am on medication because of this incident. Every year on the anniversary date, I would have to check into the hospital." VI#1 was advised a copy of this report would be on file. VI#1 could not advise the following: type of vehicle Eric and Lisa were driving, name of the bar that she was at, name of the hospital she was taken to, and if a police report was completed. VI#1 was advised a copy of this report will be forwarded to St. Bernard Sheriff's Office and Department of Defense-Army.
